

Terms and conditions inconsistent with, or contrary to the terms and conditions of this Addendum and the Master Price Agreement, together with its exhibits, shall not be added to or incorporated into this Addendum or the Master Price Agreement and its exhibits, by any subsequent purchase order or otherwise, and any such attempts to add or incorporate such terms and conditions are hereby rejected. The terms and conditions of this Addendum and the Master Price Agreement and its exhibits shall prevail and govern in the case of any such inconsistent or additional terms.


7. **Westlaw Order Forms:** The State of Rhode Island has reviewed West's applicable Order Forms and hereby incorporates these documents into the Minnesota Participating Addendum.
8. **Cancellation of the Participating Addendum:** At the time of termination or expiration of a Participating Addendum, any existing multi-year agreement between the Contract Vendor and a Participating Agency as allowed under the Price Schedules, will remain in effect and continue to exist under the terms and conditions of the Master Price Agreement until the term expires as set forth in that multi-year agreement.
